- 5. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.

- 6. It will continue to pay revised Annual Fee of Rs.3000/- p.a. The schools run by KV/NVS/CTSA/Govt. /Govt. Aided are granted regular affiliation and these schools have been advised to remit prescribed annual fee by D.D. in favour of Secretary, CBSE, payable at Delhi. This may be complied in future.
- 7. Annual fee has been received upto 31/03/2015.
