5. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.

6. It will continue to pay revised Annual Fee of **Rs.3000/- p.a.** The schools run by KV/NVS/CTSA/Govt. /Govt. Aided are granted regular affiliation and these schools have been advised to remit prescribed annual fee by D.D. in favour of **Secretary, CBSE, payable at Delhi.** This may be complied in future.
